

Consent For Treatment at Bodylogics and Terms of Business

- By booking with Bodylogics you are doing so on the understanding that you have read our cancellation policy.
- I consent to the assessment and treatment recommended and performed by Bodylogics Health and Fitness Clinic in accordance with the CSP Professional Guidelines, Society of Sports Therapist Guidelines, GOsC Professional Guidelines, BA Professional Guidelines. This may include mobilisations, manipulation, manual therapy techniques, soft tissue massage, electrotherapy modalities or exercise therapy.
- I understand that before any treatment is carried out, a full explanation and the risk of that treatment will be provided.
- I understand that should I wish to decline any form of assessment or treatment, then I am entirely within my right to do so and that I should inform the treating clinician of my wishes at the time.
- I understand that it is important that I give the most accurate health history and information to my clinician so that any planned treatments and therapies are in my best interest.
- By signing this agreement you agree to disclose any medical conditions the clinician is required to know about such as, Diabetes, Epilepsy, Heart conditions, High blood pressure, Pacemaker, Metal implants and pregnancy or anything which may effect the treatment procedures that will occur.
- I am aware that I may be asked to expose some parts of my body for treatment to take place.
- I am aware that in some cases a recording of our conversation may be taken in order to assist the therapist with accurate note taking through the use of our patient note taking app. All private and confidential data will be removed from these notes and only medically relevant data will be stored. If you wish for this to not happen in your appointment then please ensure you speak directly with your therapist.
- I understand that payment is required after each attended session. I also agree to acknowledge, and adhere to, any of Bodylogics cancellation policies for any future appointments that may be created or accepted verbally by myself. I acknowledge the 24 hour cancellation policy and understand it is my responsibility to contact and change any future appointments before this time limit. I acknowledge that my card details will be held on file and my account charged if I fail to attend any appointments or fail to inform Bodylogics within the 24 hour cancellation period.
- For those attending via their private healthcare providers, you consent to us storing and charging your card for any excess payments due. Notification will be given before this occurs. This is in line with your healthcare insurance details whereby any excess due is to be settled by the patient directly. We will do all we can to ensure you are notified of any charges by email.
- Bodylogics Health and Fitness Clinic collects personal data to enable day to day administration. Your name address, email, phone number, DOB and GP/Consultant details are stored safely by Bodylogics Health and Fitness Clinic and will never be shared without your prior consent.
- Your medical details are stored for 8 years which is the national legal requirement.
- We also collect data to assist in the administration of our businesses to provide you with an effective service. We would like to use your contact details to assist with the administration

of your appointments/changes to scheduled appointments and/or reminders about appointments. To further enhance our service to you, we would like to be able to update you on any information regarding the practice.

- We take your privacy seriously and will take all reasonable steps to ensure the protection of your data. Please note that your right to be forgotten cannot override the legal requirements to keep medical notes for the mandatory periods. You can request a copy of any data held about you by submitting an Access Request.
